The United States of America, by and through the United States Attorney for the Eastern District of North Carolina, hereby submits this Request for Corrections to the transcript of the evidentiary hearing conducted in this matter from September 17, 2012, to September 25, 2012, Docket Entry 323 and, in support thereof, shows unto the Court the following.
